ⁱ The FY 2019, FY 2020, and FY 2021 White House budgets both called for combing CHGME with Medicare and Medicaid GME in a single new mandatory capped grant program. Because of the inclusion of this proposal for changing the funding stream for CHGME, the FY 2019, FY 2020, and FY 2021 budgets included \$0 for separate discretionary funding for CHGME.

ⁱⁱ The FY 2017 White House budget called for converting CHGME to mandatory funding in the amount of \$295,000,000.

ⁱⁱⁱ CHGME for FY 2013 was funded at \$251,166 million, reflecting a continuation of level funding from FY 2012, minus a 5% across-the-board cut applied to non-defense discretionary spending resulting from sequestration.

^{iv} With a 0.189% across the board cut on Labor-HHS programs, the final total amount for CHGME in FY 2012 should have been \$267.848 million. However, the amount \$265.2 million was cited in the President’s budget and by the House and Senate Appropriations Committees as “previous year funding.”

^v Neither the House of Representatives nor the Senate passed an FY 2011 Labor-HHS appropriations bill. The Continuing Resolution (CR) to fund the government for FY 2011 did not specifically reference CHGME. Except for spending levels specifically identified in the CR, the bill gave discretion to individual agencies on funding levels for some individual programs. HRSA cut the CHGME program by 15.2%.

^{vi} The original Labor-HHS-Education Appropriations bill included \$307 million for CHGME without an across-the-board cut. That bill was vetoed by President Bush. The final appropriation for CHGME was contained in the Consolidated Appropriations Act, which included a 1.747% across-the-board cut to all discretionary programs in the Departments of Labor, Health and Human Services and Education.

^{vii} Final amount reflects an across-the-board reduction of 1% applied to all accounts.

^{viii} Final amount reflects an across-the-board reduction of .8% applied to all accounts.

^{ix} Final amount reflects an across-the-board reduction of .59% applied to all accounts.

^x Final amount reflects an across-the-board reduction of .65% applied to all accounts.
